

# The BIIAB Level 2: Award for Personal Licence Holders (APLH)

---

## **What is the APLH?**

It is a legal requirement in England and Wales that anyone who sells alcohol, or authorises the sale of alcohol, to the public, **must** be a personal licence holder.

Anyone wishing to obtain a personal licence must produce proof that they hold a licensing qualification such as the BIIAB APLH certificate.

## **How long is the training course?**

Our APLH qualification is designed in such a way that it can be delivered and examined in one day. The course comprises a mixture of self-study and teaching. At the end of the course, delegates will take a short multiple-choice examination comprising with 40 questions covering all aspects of the law and social responsibilities in relation to the sale of alcohol to the public.

Delegates will receive a course handbook, which covers all the information needed for the exam and serves as a point of reference for the future.

## **Where can I take the qualification?**

We have 32 training centres across the UK at which we offer the BIIAB APLH qualification. Courses are run regularly at each venue throughout England and Wales. ## **What does this qualification cover?**

The BIIAB APLH covers the syllabus set by government to enable candidates to understand the law in relation to:

- *the roles, responsibilities and functions of licensing authorities within the framework of the licensing objectives*
- *the application process for a personal licence*
- *the role and legal responsibilities of the personal licence holder, and the penalties relating to failure to comply with the law*
- *the premises licence*
- *the content and purpose of operating schedules*
- *the role and duties of the designated premises supervisor*
- *unauthorised licensable activities*
- *permitted temporary licensable activities*
- *rights of entry to licensed premises*
- *police powers with regard to suspension and closure of licensed premises*
- *the specific prohibitions for the sale of alcohol*
- *the strengths of alcoholic drinks, and the effects of alcohol on the human body*
- *the protection of children from harm*
- *the responsible retail sale of alcohol.*
- *what the licensing objectives are*
- *the duty to declare relevant criminal offences when making an application for a personal licence*
- *the duty to produce a licence when required by specific personnel*
- *which authorities have the right to enter licensed premises, their powers and the circumstances under which they can enter*
- *the law and consequences of breach in relation to the sale of alcohol to children*
- *the law and consequences of breach in relation to the consumption of alcohol by children*
- *the circumstances when there is a duty to refuse service to a person who is drunk.*

## **Who should take this qualification?**

**Anyone who wishes to work in a licensed premises or any venue or site where alcohol is sold, for drinking on or off the premises - in a position where they will authorise the sale of alcohol to the public.**
